

## **STAR OF KOLAR 2022 {Season 2}**

- o ***“Star of Kolar”*** is a singing and dancing show in two categories conducted by Highway Star Events (“HSE/ The Company/ Organiser”)
- o The Participant(s) must be citizens of India and must have a valid nationality proof like passport, PAN Card, Ration Card, Aadhar Card etc., with address to be in Kolar (Kolar district) and the Participant(s) shall produce such documents at the time of registration to the Organising team/HSE.
- o The Participant(s) should be of sound mind and health and must not be disqualified by law or have any criminal record.
- o The Participant(s) must satisfy the age criteria (as mentioned below) as on September 01, 2022 (“Participants”) who can participate after being registered by the process mentioned hereunder (“Entries”).
  - **Solo Singing: 16 to 40 years**
  - **Solo Dance: 16 to 35 years**
  - **Group Dance: Junior Group – 10 to 16 years**  
**Senior Group – 16 to 35 years**
- o **REGISTRATION PROCESS:**
  - The Online registrations shall commence from September 1st, 2022 and shall be open till September 10th, 2022 and others can register through on spot registration which will be held at Highway Star, Kolar on 3rd and 4<sup>th</sup> of September 2022 between 10:30 am to 5:30 pm.
  - **Required Documents: 1) Aadhar/ PAN/ DL/ Any Govt issued ID proof** with Kolar/Kolar District Address – Original & 1 copy of Xerox
    - 2) Passport Size Photo (Colour) – 1 No**
  - **Registration Fee: 1) Solo Singing & Solo Dance: INR 300**  
**2) Group Dance: INR 1000**
  - **Online Registration: Participants can use the registration link on <http://sok.highwaystarindia.com/> . This form doesn’t allow payments and the Registration Fee to be paid at Highway Star, Kolar - SOK Desk from September 1<sup>st</sup> to September 10<sup>th</sup>, 2022. (Passport size Photo to be submitted at the time of registration)**

- o Organizers shall be entitled to verify the Entry(s) or seek for such proof from the Participant(s) as shall be necessary in respect of the entries at any time as they shall deem necessary.
- o **The Participant (s) can participate in more than 1 (up-to 2 categories)** and audition Performance must conform to the following requirements:
- o The Audition shall be of the Participant himself/ herself singing clearly. No humming is allowed.
- o Audition music must NOT contain material which is sexually explicit, obscene, pornographic, violent (for example, relating to murder, weapons, cruelty, abuse, etc.), discriminatory (based on race, sex, religion, national origin, physical disability, sexual orientation or age), illegal (for example, underage drinking, substance abuse, computer hacking, etc.), offensive, threatening, profane or harassing.
- o Audition performance must NOT include, mention or feature any uncleared copyrighted material.
- o Audition performance must NOT contain derogatory references to the Production House, the Company, Highway Star, Kolar, etc.
- o Audition performance must NOT include any third party trademarks, logos, insignia, location signage, etc.
- o Neither HSE nor the Organisers will be liable or held responsible in case of any disputes / copyright issues with respect to the Audition Videos uploaded on to the Website by the Participant(s)
- o HSE/Organisers House will be given the undisputed right to use the Audition Videos by the Participant and to cut / edit / alter the same to suit its use in promotion of the Show and / or post it on its Website or any medium in any manner now known or hereinafter invented, without the approval of the Participant. Uploading the Audition Video by HSE on any Platform will in no case be the indicator of selection of the Participant in the Competition.
- o HSE has the right to reject any participant auditions in case it feels that the same is inappropriate or for any other subjective reason such as, not meeting its creative standards, not clear or does not meet the standards as per the Programming Code in the MIB Advisory.

- o All Audition shall be internally evaluated and selected by HSE creative team/ Organisers House. HSE is not liable to disclose its scoring / selection process and will not entertain any questions with respect to the same.
- o HSE/Organisers will not be responsible for the any poor quality of audition music submitted by the organisers and consequences there-of.
- o By submitting the registration form, the Participant hereby grants to HSE, in perpetuity, an exclusive, irrevocable, royalty-free, sub-licensable and freely transferable right to use, reproduce, distribute, prepare derivative works of, display, adapt, reformat, translate, and otherwise exploit and perform all or any portion of the Audition Videos for any purpose whatsoever, throughout the universe, including, without limitation, in connection with (i) the Show, including, without limitation, advertising, marketing, promotion, merchandising and the exploitation of any and all ancillary and subsidiary rights, and redistributing part or all of the Show (and derivative works thereof), and (ii) the business of Organizers network of Internet websites, wireless applications, interactive television, video on demand and any other media or technology (including, without limitation, Internet protocol, wireless or interactive platforms or interfaces) through which the Organizers may distribute content to end users, whether now existing or hereafter developed (together, the "Platforms"), in any and all media formats and through any and all media distribution and advertising and promotional purposes, without accounting, notification, credit or other obligation to the Registrants.
- o Any attempt to deliberately damage or undermine the legitimate operation of Auditions may be a violation of criminal and civil laws and should such an attempt be made, HSE reserves the right to seek damages to the fullest extent of the law.
- o The Participant acknowledges and agrees that HSE, their agencies, web masters/suppliers, contractors and vendors are not responsible for any costs, injuries, losses, or damages of any kind arising from or in connection with: technical glitches/ force majeure and other natural condition which cause delay/ rescheduling of the auditions/ Round1/2/semifinals/finals.
- o HSE/Organisers shall in their sole discretion, select the Participants for the auditions in Highway Star Kolar, after carrying out relevant check of the Entries by the Participant (s).
- o HSE/Organisers shall be under no obligation to select all or any of the Participant(s) from the Entry(s) and shall have the absolute and sole discretion to select such Participant (s) as it deems fit for the purpose of the Show. By agreeing to the present Terms and Conditions, Participant (s) waive their right to object to the selection process of HSE/Organisers or file a claim against HSE/Organisers

- o The short listed Participant(s) shall be notified through an email by HSE of the dates and timing of further on-ground audition rounds held in Highway Star.
- o HSE shall be entitled to verify the Entry(s) or seek for such proof from the Participant(s) as shall be necessary in respect of the entries at any time as the HSE shall deem necessary.
- o HSE/Organisers shall not be liable for any transportation cost incurred by the shortlisted candidates to reach the venue for on-ground auditions.
- o HSE/Organisers has the right at any time to require proof of identity and/or eligibility. Any failure to provide such proof within a reasonable time could result in disqualification from the Auditions. All personal details and information requested by and supplied to HSE/Organisers by Participant(s) must be truthful, accurate and in no way misleading. HSE/Organisers reserves the right to disqualify any Participant(s) from the Auditions in its sole discretion, should the Participant(s) at any stage supply untruthful, inaccurate or misleading personal details and/or information.
- o HSE has the right to share the contact details of the shortlisted candidates to the sponsors and partners of the Show for the sole purpose of promotion of the Show.
